



## **Job Description: AmeriCorps Girl Scout Leadership Experience Facilitators**

**Position Overview:** Making the world a better place starts with you! As an AmeriCorps member at Girl Scouts of Southeastern New England (GSSNE), you will play a pivotal role in building and expanding opportunities for youth aged 5 to 18 across Rhode Island. This position focuses on breaking barriers to participation in traditionally marginalized and underserved communities while growing your transferable skills in education, recruitment, management, and program facilitation.

### **Key Responsibilities:**

- **Program Facilitation:** Lead and facilitate youth-led, high-quality, badge-earning programming that aligns with the Girl Scout Leadership Experience. Programs will emphasize holistic well-being, career exploration, workforce development, and civic leadership.
- **Supportive Mentoring:** Provide mentorship and guidance to girls, helping them develop skills in goal-setting, decision-making, and community engagement through hands-on activities and cooperative learning.
- **Community Engagement:** Engage volunteers and recruit new Girl Scouts from diverse backgrounds and communities. Foster a welcoming environment that encourages participation and supports the growth of membership.
- **Educational Impact:** Implement evidence-based programming that supplements STEM and ELA standards, supporting educational initiatives such as Governor McKee's Learn365RI.
- **Organizational Growth:** Make a lasting impact on Girl Scouts of Southeastern New England by contributing to the organization's growth and community impact.

### **Qualifications:**

- Commitment to community service and empowering youth, particularly in underserved communities.
- Strong organizational and interpersonal skills to effectively engage volunteers and build collaborative relationships.



- Ability to work independently and as part of a team, demonstrating leadership and initiative in program implementation.
- Experience and/or interest in education, youth development, mentoring programs, or community outreach
- U.S. citizen or legal permanent resident and authorized to work in the U.S.
- Age 18+
- Able to pass a criminal background check.

- Earn an annual living allowance (up to \$26,000) and qualify for an education award (\$7,395) upon successful completion of the AmeriCorps service term.

**Working Conditions:**

- This is a full-time AmeriCorps position requiring occasional evening and weekend hours to accommodate program activities and community events.
- Travel within the Southeastern New England region may be required for program delivery and volunteer engagement.
